The 330,354 shares includes 285,712 shares of Common Stock and 44,624 shares of Common Stock issuable upon exercise of warrants. Clients of Bleichroeder have the right to receive and the ultimate power to direct the receipt of dividends from, or the proceeds of the sale of, such securities. 21 April Fund, Ltd.,a Cayman Islands company for which Bleichroeder acts as investment adviser, may be deemed to beneficially own 260,161 of these 330,354 shares, which equates to 13.14% of the Common Stock believed to be outstanding. 21 April Fund, LP, a Delaware limited partnership for which Bleichroeder acts as an investment adviser, may be deemed to beneficially own 70,193 of these 330,354 shares, which equates to 3.54% of the Common Stock believed to be outstanding.
